# PEGUIS FIRST NATION'S HONOURING OUR CHILDREN, FAMILIES AND NATION ACT

## Coordination Agreement Signing

*January 31, 2023*

Treaty One Territory – Winnipeg, MB – today Peguis First Nation, Peguis Child & Family Services (the “Agency”), Canada and Manitoba have joined together to sign a coordination agreement pursuant to An Act respecting First Nations, Inuit, and Metis children, youth and families, which will support the implementation of Peguis First Nations child and family services legislation titled Honouring our Children, Families and Nation Act (the “Peguis Act”) which has the force of law as federal law.

The Peguis Act sets out standards for global service delivery that the First Nation aims to provide for Members whomever may request services. The legislation is national in scope, which allows Members to receive child and family services from the Agency wherever they may reside in Canada.

The legislation has a focus on prevention so that families can receive supports to remain together. The impacts of colonization, intergenerational traumas and government policies have done significant damage to First Nation societies. This legislation is not a cure-all for these impacts, but provides resources, in a culturally appropriate way for Peguis families and children to deal with these impacts so that their healing can begin.

Taking into account the principle of seven generations, the legislation will have lasting impacts into the future for Peguis Members. At the same time, the inherent right and self-determination of Peguis First Nation moves forward as it reasserts jurisdiction for child and family services. In addition, the implementation of the United Nations Declaration on the Rights of Indigenous Peoples, as well as being informed from the Truth and Reconciliation

Commission Calls to Action, the Calls for Justice from the Final Report of the National Inquiry into Missing and Murdered Indigenous Women and Girls, have provided support in order to deal with the long-term negative impacts noted above.

Peguis, the Agency, Canada and Manitoba acknowledge the shift towards recognition and acknowledgement of the inherent jurisdiction of Peguis and the movement towards truth and reconciliation.

Our collective history has informed us so that we know what needs to be accomplished in the future for our families. The Honouring our Children, Families and Nation Act provides a framework to help build that brighter, healthier future for Peguis First Nation families.

Peguis First Nation is proud to confirm



the coordination agreement with Peguis Child and Family Services, Canada and Manitoba. The Honouring our Children, Families and Nation Act coordination agreement has allowed all parties to find the common ground for required service delivery for our Members. Our Nation is exercising its inherent rights and ensuring that our Indigenous Legal Traditions and teachings have formed the basis for our law. Our law requires a stronger focus on keeping families together and ensuring our Nation's values and beliefs guide how we support our families and children. On behalf of our Nation we thank the Agency, Canada and Manitoba for their collaboration and commitment to this process. – Chief Glenn Hudson

Today we are surrounded by our wonderful Elders as well as being witnessed by our Ancestors as we conclude this part of our journey towards the full operationalization of the Honouring our Children, Families and Nation Act. Our vision of success is one where each and everyone from our Nation is strong, healthy, empowered, engaged and enjoying an enhanced quality of life. The coordination agreement provides us the ability to fully implement our law ensuring that it moves us forward in the direction of this vision. With a focus on

prevention and reunification, we will be the helpers to our families that require assistance on their healing journeys. The coordination agreement is the final necessary step where we can truly provide services with the goal of this vision in mind. I acknowledge and say Gitchi Miigwetch to Creator, Spirit, our Grandmothers and Grandfathers as well as our Spirit Helpers as we share this beautiful human experience on Mother Earth. – Executive Director, Peguis CFS Clemene Hornbrook

# PFN GENERAL ELECTION 2023

## Peguis First Nation General Election 2023

### ELECTION DATE: APRIL 6, 2023

The term for Peguis First Nation Chief and Council expires on April 6, 2023; and, Peguis First Nation is required to have a General Election which must be called by January 21, 2023, under the current Indian Band Election Regulations; and, Peguis First Nation General Election will be held April 6, 2023; and, Peguis First Nation nomination meeting will be held on February 22, 2023; and, One Feather has been appointed the Electoral Officer for the Peguis Band 2023 General Election.

The Peguis First Nation (PFN) has opted into the First Nation Election Act (FNEA); and, The PFN will consist of one (1) Chief and six (6) Councillors. The quorum will be four (4); and, The Peguis First Nation Election Day will be held on Thursday, April 6, 2023; and, The term of office will be a four (4) year term ending April 6, 2027; and, Chief and Council accept the recommendations of the Electoral Officer in their notice to the community as attached. Therefore the 2023 Election for Chief and Council of the Peguis First Nation shall be as follows:

# NOTICE OF NOMINATION MEETING

Notice is hereby given that a meeting of the Eligible Electors of the Peguis First Nation will be held in the PEGUIS COMMUNITY HALL ON FEBRUARY 22, 2023 from 4:00 – 7:00 PM local time AND LASTING FOR AT LEAST 3 HOURS, for the purpose of nominating one (1) candidate for the Office of Chief and six (6) candidates for the Office of Councillor for the next ensuing term.

### IMPORTANT INFORMATION ABOUT THE NOMINATION OF CANDIDATES:

1. Any elector may nominate candidates by delivering or sending by mail or email to the Electoral Officer a completed, signed and witnessed nomination and voter declaration form to the Electoral Officer before the time set for the nomination meeting, OR by making a nomination orally at the nomination meeting.
2. Under the *First Nations Elections Act*, an elector must not nominate more than one candidate for the position of chief and no more candidates for the position of Councillor as there are Councillor positions available for election.
3. Under the *First Nations Elections Act*, a nominee does not become a candidate until they deliver to the Electoral Officer or Deputy Electoral Officer, by 6:00 PM on February 25, 2023 a signed *Candidate Declaration* form, which can be obtained from the Electoral Officer.

### IMPORTANT INFORMATION ABOUT THE ELECTION:

1. The election will be held at the PEGUIS COMMUNITY HALL on APRIL 6, 2023 from 9:00 AM to 8:00 PM.
2. The Advance Polls will be held at:
  - Peguis: PEGUIS COMMUNITY HALL on March 28, 2023 from 9:00 AM to 8:00 PM.
  - Winnipeg: HILTON WINNIPEG AIRPORT SUITES 1800 WELLINGTON AVE., WINNIPEG, MANITOBA on March 30, 2023 from 9:00 AM to 8:00 PM.
  - Selkirk: 240 MAIN ST., SELKIRK, MANITOBA on March 31, 2023 from 9:00 AM to 8:00 PM.
3. Any elector may vote by mail-in ballot by submitting a Request for Mail-in Ballot Form, which can be obtained from the Electoral Officer, along with a copy of identification, prior to MARCH 31, 2023. The elector is responsible for ensuring they request their mail-in voting package in a timely manner to ensure it can be received and returned via regular post and received by the Electoral Officer on or before APRIL 4, 2023.
4. Any elector may permit the electoral officer to release their name to the candidates.

The Income Assistance Department is now doing intake (applying for assistance) through appointment only. This process is to assist the client with obtaining any missing documentation.

Appointments are available upon request. No appointments will be booked after 3:30 pm. Reminder to bring in required documents to the appointment. If you are missing documents, the IA department will assist with the obtaining required items. Walk ins will be assisted on emergency basis.

As of February 7, 2023, New Application deadline will be after the 20th of each month.

### MARCH 1, 2023, ISSUANCE

All clients will receive their benefits for the month of March. No bi-weekly cheques will be issued. This is due to the fiscal year end.

### 2022 TAX YEAR/CERB

If you have received CERB benefits and were ineligible, you may not receive cost of living. It is advised that clients call 1-800-959-8281 or check CRA account to verify if any amount is owing to the Federal Government.

Documentation can also be dropped off at the Peguis Band Office. The IA office voicemail is now actively working. All calls will be returned within 12-24 hours except for urgent matters.

**Reminder:** For those who receive formula supplements, all receipts must be equal or close to the amount of \$171.06. No payments will be processed until all receipts are received.

*Rate change for economic* is as follows: previous basic need rate \$222.00, new rate is now \$272.00

*Rate change for economic couples*, with no children: previous rate \$386.00, new rate is now \$486.00

*Rate change for Disability clients:* previous rate \$105.00, new rate \$130.00

All rate changes are for those who were eligible as per ISC Policy.

### NON-INSURED NIHB MEDICATIONS

Peguis Income Assistance Department will no longer cover the cost or reimburse parents for children who are not registered with treaty status (children with no treaty number) from the ages of 3-17.

As of January 19, 2023, in conjunction with regional Jordan's Principle, Grand Medicine is now taking prescriptions for those children who are not currently registered with treaty status.

The process is as follows:

- Prescription to be taken to Grand Pharmacy
- Parent is to sign a consent form and await approval. Processing time for ap-proval is 12-48 hours.

It is the responsibility of the parent/legal guardian to ensure your child is registered and has a valid Treaty Status Card. Applications for registration are available at the Band Office with the Membership Department.

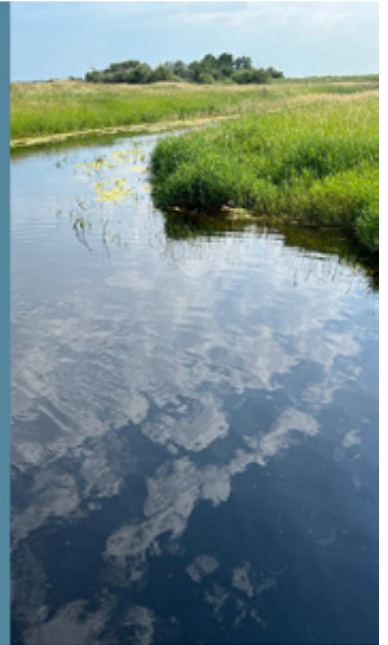
